Reason for requesting extension to submit Annual Report

In light of the public health emergency here in the country and around the world, we write to request an extension to file the Corporation's Annual Report (SEC FORM 17-A) and the attached Sustainability Report, as well as the Audited Financial Statements for the year ended 31 December 2019 as permitted under SEC Memorandum Circular No. 5, series of 2020. While our operations as a money remittance business is still ongoing, the Corporation and its foreign subsidiaries have only retained a skeletal workforce in line with the physical distancing measures implemented here in the country through the Enhanced Community Quarantine (ECQ) in Luzon and certain provinces in Visayas and Mindanao, and in countries affected by COVID-19 where our foreign subsidiaries and associates operate (i.e. Italy, Spain, Canada, Hong Kong, Singapore, Australia). As we have both domestic and foreign operations, we respectfully request an extension until 30 June 2020 or until 60 days after the lifting of the public health emergency in the Philippines, whichever comes later, to file the aforementioned reports.

The disclosure is amended to submit the attached SEC Form 17-LC as required in SEC Notice dated 03 April 2020.
